Gloria L. Gordon	Police	\$ 35	Ms. Gordon is an Intermediate Typist. She suggested that Officers' Report Slips be eliminated for bicycle impounds since the same information is contained on Property Tags. This saves an estimated \$315 annually.
Linda H. Knarreborg	City Clerk	\$ 35	Ms. Knarreborg is an Intermediate Clerk. She developed a set of instructions for processing appeals. This saves an estimated \$352 each year.
Elizabeth L. Deeg	City Clerk	\$30	Ms. Deeg is an Intermediate Typist. She suggested that a stamp be used to place identifying information resolution and ordinance index cards. This saves an estimated \$282 annually.
German Gonzalez Dennis M. Grady	Personnel	\$ 20	Mr. Gonzalez and Mr. Grady are Associate Personnel Analysts. They suggested that internal copies of revised Personnel Manual Sections be restricted in number. Estimated annual savings is approximately \$200.
