WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Lucille S. Alexopoulos	Risk Management	\$ 20	Ms. Alexopoulos is a Senior Typist. She suggested that the General Accident Report be a single sheet report. This eliminates unneeded NCR copies and saves approximately \$217 annually.
Elizabeth L. Deeg	City Clerk	\$ 15	Ms. Deeg is an Intermediate Typist. She copied the Resolution Index File to be used as a reference guide for inquiries by City departments. This eliminates the guesswork for the employees making inquiries.
David R. Warfield	Fire	\$ 15	Mr. Warfield is a Fire Captain. He suggested that only the summary sheet of current job openings be sent to Fire Stations. This is expected to save \$250 annually in printing costs. This is a partial award pending a final 12-month review
E. Lorraine Payne	Risk Management	\$ 15	Ms. Payne is an Intermediate Typist. She suggested that the Group Insurance Office stop receiving notices of service and disability retirements. This saves both paper and time.
Dennis M. Grady	Personnel	\$ 10	Mr. Grady is an Associate Personnel Analyst. He suggested that job advertisements not go through the Nationwide Advertising Service. This is not being done, but it led directly to a lower rate being negotiated with one newspaper. This is a partial award pending a final 12-month review.
