WHEREAS, the Planning Commission held public hearings on October 12, 1978 and January 4, 1979, to consider the proposed "Greater Golden Hills Precise Plan" superseding portions of two existing adopted plans, the Park North-East and Southeast Community Plans, prepared by the City Planning Department under the direction of the City Council; and

WHEREAS, the "Greater Golden Hills Precise Plan" was developed with the overriding objectives for preserving the existing residential character yet accommodating a population increase, retaining the low and moderate income housing, maintaining the heritage of Golden Hills, maintaining the socially and economically diverse community, concentrating future commercial activities and enhancing the physical and social environment; and

WHEREAS, the Planning Commission approved and recommended to the City Council adoption of the "Greater Golden Hills Precise Plan" and further recommended recision of portions of the Park North-East and Southeast Community Plans; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the Greater Golden Hills Precise Plan; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:
