
BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that a portion of lot "A" shown as Reserved For Future Street on the Map of Pacific Valley Estates Unit No. 1, according to Map thereof No. 3681, a copy of which said map was filed for record in the San Diego County Recorder's Office, as more particularly shown on Drawing No. 14566-B on file in the office of the City Clerk as Document No. 765751, which is by this reference incorporated herein and made a part hereof, be, and the same, are hereby set aside and dedicated as and for a public street, and the same is hereby named GREEN BAY STREET.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and is hereby directed to file a certified copy of this resolution in the office of the County Recorder and the County Surveyor of San Diego County.
