WHEREAS, Ronald L. Barrett has developed an amateur radio parts company called Pride Electronics which has in three years progressed from a \$400 budget to a \$5 million a year enterprise; and

WHEREAS, the development of that company was strongly influenced by the almost 80% employment of physically and mentally handicapped personnel; and

WHEREAS, the initial hiring of the handicapped was implemented through the use of a CETA grant but has since the end of the first year been continued with no grant assistance; and

WHEREAS, Ronald L. Barrett has been previously honored by the Governor of the State of California as Small Business Employer of the Year of 1976 and by the President of the United States as Small Business Employer of the Year of 1977; and

WHEREAS, Mr. Barrett, as a former City employee with the City Manager's office and as an Administrative Assistant in the Fourth District Council office, held and maintained an active interest in handicapped employment; and

WHEREAS, as a private employer, Mr. Barrett continues to this day in his policy of hiring, training and promoting handicapped individuals; NOW, THEREFORE,
