WHEREAS, Bernardo Center Drive is shown on the Progress Guide and General Plan of the City of San Diego, adopted by the City Council on January 27, 1972; and

WHEREAS, Bernardo Center Drive is shown on the Community Plan of Rancho Bernardo, adopted by the City Council of San Diego; and

WHEREAS, Freeway Route 15 is on the Interstate System and is shown on the Regional Transportation Plan of Freeway and Expressway System adopted by the Comprehensive Planning Organization in April, 1977; and

WHEREAS, the California Highway Commission authorized the connection of the two southerly ramps at Bernardo Center Drive to the then U. S. 395, now Interstate 15, on October 30, 1963; and

WHEREAS, the State has initiated action to provide a new freeway connection in the form of the two northerly ramps on Interstate 15 at Bernardo Center Drive on the basis of eliminating wrong-way traffic movements; and

WHEREAS, AVCO Community Developers, Inc., has agreed to provide the necessary right-of-way at no cost to the City or State; and

WHEREAS, the City of San Diego would benefit greatly by the addition of the new connection by providing increased traffic circulation within the community or Rancho Bernardo; NOW,  
THEREFORE,


