WHEREAS, during the morning of Monday, January 29, 1979, rifle shots were fired by a sniper into the schoolyard of Cleveland Elementary School in San Carlos as hundreds of children were arriving for classes; and

WHEREAS, after the initial shots were fired, MR. BURTON A. WRAGG, Principal of Cleveland Elementary School, ran to the aid of wounded children in an area in front of the school which was exposed to gunfire; and

WHEREAS, MR. WRAGG was shot and mortally wounded as he bent to help a small child who had been felled by the sniper's shots; and

WHEREAS, MR. WRAGG, who dedicated his career to the education of the young people of San Diego, ultimately gave his life in attempting to protect the students and staff in his charge; and

WHEREAS, MR. WRAGG'S quick action and self-sacrifice greatly reduced the number of casualties during this tragic incident; and

WHEREAS, colleagues of MR. WRAGG have described him as a man whose competence and dedication and sensitivity won him the respect and admiration of his fellow administrators, teachers and students under his charge; NOW, THEREFORE,

BE IT RESOLVED that the City Council of the City of San Diego expresses its deep admiration and appreciation for the dedicated career and heroic final act of

and extends its heartfelt sympathy to his family on behalf of the people of San Diego.
