

City of San Diego and of each and every claim against the City of San Diego, its agents and employees, resulting from the personal injuries to the Baker Family and the death of Kenneth Baker.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the total amount of \$107,500.00 made payable to the Clerk of the Superior Court in full settlement of the lawsuit and of all claims.





## CERTIFICATION OF UNENCUMBERED BALANCE


