
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM GREGORY CLARKE, a Licensed Land Surveyor, entitled "CASA GOLD COAST Being a subdivision of Lots 1675, 1676 of Mira Mesa Verde Unit No. 13-A, according to Map thereof No. 6820 filed in the office of County Recorder of San Diego County on January 18, 1971 and Lots 1678, 1680, and 1681, inclusive, of Mira Mesa Verde Unit No. 13-B, according to Map thereof No. 6897 filed in the office of County Recorder of San Diego County April 8, 1971, all being in the City of San Diego, County of San Diego, State of California, together with portions of Camino Ruiz, Jade Coast Road, Flanders Drive, Gold Coast Drive and Reagan Road as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse said map, as and for the act of the Council, that said Council has approved said subdivision map.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
