- 1. That the City Manager be and he is hereby authorized to submit grant applications to the Federal Aviation Agency (FAA) for funding of Airport Master Plan and Airport Land Use Plan Studies for Brown Field and Montgomery Field under the FAA's Planning Grant Program.
- 2. That this Council hereby concurs in the selection of ${

 m M}$ Hill Inc. as the consultant firm to perform the Master Plan Studies.
- 3. That this Council concurs in the recommendation that the Comprehensive Planning Organization (CPO), as the designated Airport Land Use Commission for the region, perform the Airport Land Use Plan Studies.
- 4. That the City Manager be and he is hereby authorized to negotiate the necessary agreements with CH₂M Hill and CPO, pending receipt of the FAA Grant and subject to Council approval.
- 5. That the CPO Board of Directors is hereby urged to seek FAA Planning Grant Funds for an update of the regional Airport Systems Plan (SANPAT).
- 6. That an amendment be and it is hereby authorized to amend the fiscal year 1979 Capital Improvements Program by adding to the title of CIP 31-018; Brown Field Runway Lighting,

the words, "including preparation of an Airport Master Plan and Airport Land Use Plan" and transferring \$18,000 in Capital Outlay funds from said CIP 31-018 to CIP 58-002; Special Assessment Districts, to be replaced by an equal amount of General Revenue Sharing Funds from CIP 58-002 to CIP 31-018 for the purpose of financing the Airport Land Use Plan which is ineligible for Capital Outlay funding.

That an amendment be and it is hereby authorized to 7. amend the fiscal year 1979 Capital Improvements Program by adding to the title of CIP 31-124; Montgomery Field Runway Extensions, the words, "including preparation of an Airport Master Plan and Airport Land Use Plan" and transferring \$22,000 in Capital Outlay funds from said CIP 31-124 to CIP 58-002; Special Assessment Districts, to be replaced by an equal amount of General Revenue Sharing Funds from CIP 58-002 to CIP 31-124 for the purpose of financing the Airport Land Use Plan which is ineligible for Capital Outlay funding.
