

RESOLUTION NO. 223927Adopted on FEB 27 1979

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

| <u>NAME</u> | <u>DEPARTMENT</u> | <u>AMOUNT</u> | <u>SUGGESTION</u> |
|-----------------------|---------------------|---------------|--|
| Warren E. Hall | General Services | \$1,000 | Mr. Hall is an Electronics Technician in the Communications and Electrical Division. He suggested that status scanners be constructed for the City's communications network. Mr. Hall's design reduces drastically the number of telephone lines required and saves \$63,952 annually. |
| Harry F. Haas | Police | \$ 500 | Mr. Haas is a Police Officer. He suggested that the License Tax be applied to taxicab drivers leasing taxicabs. This is expected to produce an additional \$18,750 annually in revenue. This is a partial award pending a final 12-month review. |
| Matthew E. Weathersby | Police | \$ 415 | Mr. Weathersby is a Police Officer. He suggested that permanent flash attachments be purchased for cameras rather than using flash bars. Estimated annual savings are \$8,312. This is a partial award pending a final 12-month review. |
| Alger L. Thompson | Park and Recreation | \$ 100 | Mr. Thompson is an Equipment Operator I in the Parks Division. He suggested that the tire specifications be changed for renovation tractors. This is expected to save \$1,000 annually in tire costs and wear and tear on park terrain. |
