That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Robert C. Nightingale	Planning	\$ 65	Mr. Nightingale is a Zoning Representative. He suggested that 100' scale maps be eliminated from no-hearing variances. Annual savings are \$630.
Dennis M. Grady German Gonzalez	Personnel	\$ 60	Mr. Grady and Mr. Gonzalez are Associate Personnel Analysts. They suggested that bulk mailing rates be used for mailing out large numbers of job announcements. Savings are expected to be \$1,269 annually. This is a partial award pending a final 12-month review.
Dennis M. Grady German Gonzalez	Personnel	\$ 60	Mr. Grady and Mr. Gonzalez are Associate Personnel Analysts. They suggested that job application cards be converted to post cards. This is expected to save \$1,297 annually in postage costs. This is a partial award pending a final 12-month review.
Robert C. Nightingale	Planning	\$ 25	Mr. Nightingale is a Zoning Representative. He suggested that Zoning eliminate its file of approved landscape plans since this information is available in Building Inspection. This saves \$235 annually.
