Caroline L. Steyers	Building Inspection	\$ 20	Ms. Steyers is a Senior Engineering Aide. She suggested that Form IN-172 Record of Complaint be revised. Savings are difficult to calculate, but the new form provides more and more accurate information.
Robert L. Davis	General Services	\$ 20	Mr. Davis is a Plumber in the Buildings Division. He suggested that a different type of thermostat be used. The new thermostat restricts allowed temperature extremes. Energy savings are difficult to calculate.
Donna Jaeger Roy Wehrman	Police	\$ 20	Ms. Jaeger and Mr. Wehrman are Associate Administrative Analysts. They suggested that a mirror be installed at a blind corner in the Central Station. This improves both safety and security.
Ken Anderson	Police	\$ 20	Mr. Anderson is a Police Sergeant. He suggested that in-service quizzes be answered directly on the question sheet. This is expected to save \$210 annually in the printing of separate answer sheets.
