Edna Gonzales	Police	\$ 10	Ms. Gonzales is an Intermediate Typist. She revised the internal misdemeanor citation log by eliminating one column. This saves \$89 annually.
Theresa M. Hall	Personnel	\$ 10	Ms. Hall is an Intermediate Typist. She suggested that certain bulk letters be printed in a postcard format. Savings are expected to be significant. This is a partial award pending a final 12-month review.
Yvonne M. Lewandowski	Park and Recreation	\$ 10	Ms. Lewandowski is a Center Director III in the Recreation Division. She suggested that all softball teams be required to submit the individual players' names on index cards. This will minimize the chance of one individual playing on more than one team.
