


RESOLUTION No. 222958 (R-79-1592)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$68,172.00 by T. B. PENICK & SONS INC., a corporation, for the CONSTRUCTION OF BAY BRIDGE PARK ADDITIONAL IMPROVEMENTS in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 763842.
2. That the expenditure of \$61,000.00 from Third Year Community Block Grant Fund 2930 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$28,400.00 from Fourth Year Community Block Grant Fund 2940, Element 73.95 (Contingencies) to CDBG Fund 2940, Element 73.58.
