
APPROVING MAP OF LA JOLLA SCENIC VIEW

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by
CHARLES W. CHRISTENSEN, a Registered Civil Engineer, entitled
"LA JOLLA SCENIC VIEW Being a subdivision of a portion of Pueblo
Lot 1290 of Pueblo Lands of San Diego, in the City of San Diego,
County of San Diego, State of California, according to Map thereof
made by James Pascoe in 1870, a certified copy of which was filed
in the office of the County Recorder of San Diego County, on
November 14, 1921 and is known as Miscellaneous Map No. 36, together
with a portion of La Jolla Scenic Drive as dedicated to public use.",
is made in the manner and form prescribed by law and conforms to
the surrounding surveys; that said map and the subdivision of land
shown thereon is hereby approved and accepted; and said Council
hereby accepts on behalf of the public Avenida Kirjah for public
purposes, and said street is hereby declared to be a public street
and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of water facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said



Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that those easements with the right of ingress and egress for construction and maintenance of water facilities, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
