765778 , quitclaiming to MERCY HOSPITAL and MEDICAL CENTER, a California corporation, that certain easement, as more particularly described in said quitclaim deed.

- 3. That no broker's commission shall be paid by City on the herein described negotiated sale.
- That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Engineering and Development Department Director for further handling.
