BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the bid of Herzig Corporation is hereby accepted and the City Manager is authorized to execute a contract for the installation of an automatic fire sprinkler system for the Palisades Building Schedule V, in an amount of \$62,000.

BE IT FURTHER RESOLVED, that the expenditure of \$91,000 from Balboa Park Facilities Fund 10501 is hereby authorized for the purpose of awarding the contract to Herzig Corporation and related costs.

BE FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego is authorized to advertize for bids in accordance with plans and specifications to be filed in the office of the City Clerk to provide structural repairs for the Palisades Building; these repairs are described as immediately necessary in the structural survey report prepared by Atkinson, Johnson, Spurrier, Inc., structural engineers.

BE IT FURTHER RESOLVED, that the expenditure of \$50,000 from Balboa Park Facilities Fund 10501 is hereby authorized to provide the structural repairs for the Palisades Building and related costs.
