

RESOLUTION No. 222989 (R-79-1083)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a lease agreement with MISSION BAY MARINA, a limited partnership of which COASTAL MARINE MANAGEMENT, a California corporation, dba Mission Bay Marina is the general partner, as Lessee, for the purposes of constructing, operating and maintaining marina facilities in Mission Bay, for a term of 50 years, at an initial minimum annual rental of \$20,000 versus various percentages, whichever is greater, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. 766042.
