WHEREAS, said massage establishment, nude entertainment and off-premises massage establishment licenses have been revoked and the escort service license has been suspended by the City Manager for conducting these businesses in an unlawful manner; and

WHEREAS, on March 6, 1979, the Council of The City of San Diego granted Mr. Bruce Compton a hearing appealing the decision of the City Manager to revoke and suspend said licenses, at which time the appeal was denied; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the December 8, 1978 decision of the City Manager to revoke Mr. Bruce Compton's four (4) massage establishment licenses, one (1) nude entertainment license, and one (1) off-premises massage establishment license and to suspend one (1) escort service license be and the same is hereby upheld, and the findings and conclusions in Report No. 79-60 dated January 22, 1979 are hereby adopted.
