WHEREAS, Mr. Tokichi Sakai has brought to the City of San Diego the prestigious Sakai Ukiyo-e Collection featuring the rare authentic "Thirty Six Views of Mt. Fuji," the famous wood-block print series by Katsushika Hokusai; and

WHEREAS, Haruyo Fujita, third generation master printer, and one of the few individuals still practicing this time honored craft in Japan will give demonstrations of the traditional Ukiyo-e printing technique; and

WHEREAS, the Sakai Ukiyo-e collection dates back five generations to Tokichi Sakai's great grandfather Rihei Sakai, friend and patron of Hokusai and Hiroshige two of Japan's most famous wood-block artists; and

WHEREAS, this collection of more than 100,000 prints including representative masterpieces of all known Ukiyo-e artists, is believed to be the largest of its kind in the world; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council expresses its appreciation to Mr. Tokichi Sakai for sharing with our City this valuable and prestigious collection.
