

RESOLUTION No. 223022 (R-79-1626)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of a street easement deed of THE YOUNGSON COMPANY, INC., a California corporation, executed in favor of The City of San Diego, bearing date of December 4, 1978, conveying to said City an easement and right of way for street purposes over those portions of Parcel "B" of Parcel Map No. 628 (being a portion of Pueblo Lot 1287 and a portion of Lot "D" of the Resubdivision of La Jolla Hills No. 2, Map No. 2087), as more particularly described in said deed, be and the same is hereby approved; and that the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named HILLSIDE DRIVE.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution attested by him under seal to be recorded in the office of the San Diego County Recorder.
