BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of a street easement deed of WILLIAM M. SCHNEIDER, a married man, as to an undivided one-half interest, and TERESA MARY SCHNEIDER, a married woman, as to an undivided one-half interest as tenants in common, executed in favor of The City of San Diego, bearing date of January 3, 1979, conveying to said City all that portion of Lot 20 of SOLEDAD TERRACE, as more particularly described in said deed, be and the same is hereby approved; and that the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named LOS ALTOS ROAD.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution attested by him under seal, to be recorded in the office of the San Diego County Recorder.
