BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized to transfer \$14,275 within Library Fund 100/2032 from Non-Personnel to Personnel Services, of The City of San Diego, solely and exclusively, for the purpose of setting up the branch library in Tierrasanta as part of the fourth quarter adjustments.
