BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$345,802.00 by T.B. PENICK & SONS, INC., a corporation, for the CONSTRUCTION OF MISSION HEIGHTS PARK, including Base Bid Plus Deductive Alternate Nos. 1, 2 and 3, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 765060.
2. That the expenditure of \$263,500.00 is hereby authorized out of the Third Year Community Block Grant Fund 2930 of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer a total of \$40,000.00 from Fourth Year Community Block Grant Fund 2940, Element 73.95 Contingencies to CDBG Fund 2940, Element 73.73 and authorizing the expenditure of these funds for this purpose and related costs.
