

RESOLUTION OF INTENTION NO. 223075 (R.79-1580)

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE A PORTION OF NOYES STREET ADJACENT TO LOT 20, BLOCK 213, MAPS 697 AND 854 AND FIXING A TIME AND PLACE FOR HEARING THEREOF. MAR 19 1979

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the street hereinafter mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of A PORTION OF NOYES STREET ADJACENT TO LOT 20, BLOCK 213, MAPS 697 AND 854 as more particularly shown on Drawing No. 14526-B on file in the office of the City Clerk as Document No. 765897.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 2:00 P.M. APR 24 1979 in the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.


That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in the said City
