

BE IT RESOLVED, by the Council of The City of San Diego, that the Council does hereby pledge its cooperation in the war against crime endorsed by the Public Safety Committee of the League of California Cities on January 25, 1979, in Los Angeles, California, and as set forth in Mayor Wilson's State of the City address of January 9, 1979.

BE IT FURTHER RESOLVED, that it is the intention of the City Council to develop a five-year plan for fighting crime by:

1. Adopting and supporting tough state and federal anti-crime legislation;
2. Urging judges to provide stiff sentences to repeat offenders;
3. Using the schools to curb rising juvenile delinquency by commanding respect through tougher discipline and informative programs;
4. Making a commitment to provide efficient, properly trained police;
5. Developing citizen involvement in Neighborhood Awareness Programs; and
6. Providing more prisons to keep repeat offenders off the streets.
