WHEREAS, the State of California Fair Employment Practices Act requires cities to avoid discrimination in employment opportunities; and


WHEREAS, the City Council has endorsed the concept of programs of Affirmative Action in the areas of municipal employment and contract compliance; and

WHEREAS, by Resolution No. 209737, adopted on January 24, 1974, the City Council directed the City Manager to implement the Affirmative Action Program for banks, vendors and lessees who do business with The City of San Diego; and

WHEREAS, the Affirmative Action Program for vendors as adopted by Resolution No. 209737 has been subsequently revised; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the 1979 Affirmative Action Program for Vendors doing business with The City of San Diego as set forth in Document No. 766051 is adopted and the City Manager is directed to implement this Affirmative Action Program.
