BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$16,000 within the Transient Occupancy Tax Unappropriated Reserve Fund 223 from Program Element 52.29, Contingency Reserve, to Program Element 52.30 (AAU--World Amateur Wrestling Championships), to be used solely and exclusively for the above purpose.
