BE IT RESOLVED by the Council of The City of San Diego as follows:

1. That all bids theretofore received on January 30, 1979, pursuant to publication of notice calling for bids on CONSTRUCTION OF SOUTHEAST SAN DIEGO SPORTS FIELD ADDITIONAL PARKING LOT are hereby rejected; and
2. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation, and other expense necessary of incidental for CONSTRUCTION OF SOUTHEAST SAN DIEGO SPORTS FIELD ADDITIONAL PARKING LOT, San Diego, California, filed in the office of the City Clerk of The City of San Diego, California, on MAR 15 1979 and bearing official Document No. 735840 be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Council has ascertained the current or prevailing rate of per diem wages paid by private employers in the City for each craft or type of workman or mechanic needed to execute the contract, and does hereby declare that the wage scale included in said specifications is the said current or prevailing rate for the various crafts therein mentioned.

BE IT FURTHER RESOLVED, that the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
