APPROVING MAP OF BROOKSIDE GLEN AND ACKNOWLEDGING
RECEIPT OF SUBDIVIDER'S ASSURANCE OF COMPLIANCE
WITH THE AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by PATRICK H. O'MALLEY, a Licensed Land Surveyer, entitled
"BROOKSIDE GLEN Being a subdivision of Lots 5 through 7,
10 through 22, 25 and 26 and a portion of Lot 27 of Brooklyn
Terrace Subdivision, in the City of San Diego, County of
San Diego, State of California, according to Map thereof
No. 1849 filed in the office of the County Recorder of
San Diego on August 13, 1925, together with Herrick Street
as dedicated to public use and together with the Sage Way
and right of way for drainage as closed and vacated to public
use.", is made in the manner and form prescribed by law and
conforms to the surrounding surveys; that said map and the
subdivision of land shown thereon is hereby approved and
accepted; and said Council hereby accepts on behalf of the
public Sage Way and a portion of Sixty-Sixth Street for
public purposes, and said street and portion of a street are
hereby declared to be a public street and portion of a public
street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation,
any and all abutters' rights of access in and to Herrick
Street, adjacent and contiguous to Lots 6 through 10, all
as shown on this map within this subdivision.



BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, K.O.S. DEVELOPMENT COMPANY, a general partnership, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of BROOKSIDE GLEN.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
