

RESOLUTION NO. 223112 (R.79-1748)

WHEREAS, in approving the final map of BROOKSIDE GLEN MAR 26 1979

will allow the quitclaim of existing sewer and drain easements
within the area of the subdivision; and

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That the Mayor and the City Clerk are hereby authorized
and empowered to execute, for and on behalf of The City of
San Diego, a quitclaim deed, which is on file in the office of
the City Clerk as Document No. 765982, quitclaiming
to K.O.S. DEVELOPMENT COMPANY, a partnership, all the City's
right, title and interest in the sewer and drain easements,
as more particularly described in said quitclaim deed.
