APPROVING MAP OF COLONY FOUR SUBDIVISION

MAR 26 1979

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by Roger L. Snipes, a Registered Civil Engineer, entitled "COLONY FOUR SUBDIVISION Being a subdivision of a portion of Lot "H" of Pubelo Lot 1312 of the Pueblo Lands of San Diego, according to Referee's Partition Map No. 968, filed in the office of the County Recorder of San Diego County, December 13, 1905, in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: portions of Inyaha Lane and La Jolla Shores Drive for public purposes, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for open space over, under, upon and across Lot 1, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that


