BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Drainage and Street Easement Deed of the ESTATE OF ROY M. LEDFORD, Deceased, as to an undivided one-quarter interest; and ROY MERL LEDFORD, ROY MERL LEDFORD, JR., LUCILLE CLARICE LEDFORD GREEN, ANNE LEDFORD EVANS and J.A. DONNELLEY, trustees in trust as set out in the Final Decree of Distribution of the Estate of HERMA LUCILLE LEDFORD, Deceased, as to an undivided one-quarter interest, executed in favor of The City of San Diego, bearing date of October 25, 1978, conveying to said City all that portion of Lot 18 of the Rancho Mission of San Diego, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street, and the same is hereby named 60TH STREET.


