WHEREAS, SHELL OIL COMPANY, a Delaware corporation, has requested an exchange of sewer easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be abandoned by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of SHELL OIL COMPANY, a Delaware corporation, executed in favor of The City of San Diego, bearing date of September 5, 1978, conveying to said City a sewer easement affecting those portions of the Southeast Quarter, and of the East Half of the Southwest Quarter of Section 16; and of the West Half of the Southwest Quarter of Section 15, all of Township 14 South, Range 3 West, as more particularly described in said deed, is hereby approved.



That the City of San Diego, by this resolution, does hereby abandon whatever right, title or interest it may have in the sewer easement, as more particularly shown on Drawing No. 17909-D on file in the office of the City Clerk as Document No. 766003, which is by this reference incorporated herein and made a part hereof.
