

RESOLUTION No. 223132 (R-79-1794)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to proceed as presently scheduled with actions necessary to accomplish the reconstruction of the Electric Building.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to proceed as presently scheduled with actions necessary to accomplish needed repairs to the El Centro Cultural, Conference Building, Municipal Gymnasium, Palisades Building and to take actions necessary for the installation of a sprinkler system for the House of Hospitality.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to proceed with actions necessary to hire a design consultant for the purpose of designing plans for needed repairs to the Natural History Museum.

BE IT FURTHER RESOLVED, that \$1 million of the City's share of the anticipated State surplus funds for Fiscal Year 1979 - 1980 is hereby tentatively earmarked for the reconstruction of the Old Globe Theater.

BE IT FURTHER RESOLVED, that the question of repairs to the House of Hospitality and the House of Charm is hereby deferred until the City Council considers the total City budget for Fiscal Year 1979 - 1980.
