

**RESOLUTION No.** 223137 (R-79-1863)


Adopted on MAR 26 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That a representative from the City Attorney's Office is hereby authorized to travel to Phoenix, Arizona; San Francisco, California; various Indian reservations on the Colorado River; Atlanta, Georgia and Washington, D.C., commencing March 29, 1979, to participate in the proceedings before a Special Master in the case of Arizona v. California concerning the allocation of Colorado River waters to certain Indian tribes in the Colorado Basin.

BE IT FURTHER RESOLVED, that the expenditure of \$5,000 is hereby authorized out of Water Utilities Operating Fund 500 (61.10) for the sole and exclusive purpose of providing funds for lodging, travel and miscellaneous expenses.
