

RESOLUTION NO. 223146Adopted on MAR 27 1979

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Richard J. Jinings	General Services	\$175	Mr. Jinings is an Equipment Mechanic in the Equipment Division. He suggested that the ground lead should be attached to the bolt which holds the forward clutch disc of hydraulic pump clutches. This will reduce clutch damage by an estimated \$3,510 annually. This is a partial award pending a final 12-month review.
William V. Nery Daniel A. Volk	General Services	\$140	Mr. Nery and Mr. Volk are Equipment Mechanics in the Equipment Division. They suggested that fuel filters be moved to the rear of engine trays. This eliminates the wear and tear on fuel lines and reduces the incidence of leakage and replacement. This idea is expected to save \$2,868 annually. This is a partial award pending a final 12-month review.
Beverly J. Andresen Eustis Nikas	General Services	\$140	Ms. Andresen is a Supervising Sanitation Investigator, and Mr. Nikas is a Sanitation Supervisor in the Solid Waste Division. They suggested that the bottom surfaces of City trash cans be coated with tar. This is expected to prolong the life of the cans and is expected to save \$2,766 annually. This is a partial award pending a final 12-month review.
