WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Willie D. White	General Services	\$95	Mr. White is a Laborer in the Solid Waste Division. He designed a litter container liner for City trash cans. This liner will lengthen the life of containers by not allowing liquids to come in contact with metal surfaces. This is expected to save \$1,924 per year. This is a partial award pending a final 12-month review.
John A. Baker	General Services	\$80	Mr. Baker is an Equipment Mechanic in the Equipment Division. He suggested that grease fittings be installed on the cap of the axles of trash packers. This is expected to save \$1,610 per year in axle damage. This is a partial award pending a final 12-month review.
Frank Alesi	General Services	\$60	Mr. Alesi is an Equipment Mechanic in the Equipment Division. He suggested that replacement exhaust pipes for mobile street sweepers be made to order. This saves \$602 per year in installation costs.
Kathleen D. Martinez	City Clerk	\$60	Ms. Martinez is an Intermediate Typist. She suggested that the documenting of "form of" contracts be eliminated. This saves \$621 per year.
