WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Edna Gonzales	Police Department	\$30	Ms. Gonzales is an Intermediate Typist. She revised Form PD-470, Certificate of Release so that it may be used with window envelopes. This saves \$317 annually.
Domingo Monjarez	General Services	\$25	Mr. Monjarez is an Equipment Repair Supervisor. He suggested that service station fuel hoses be suspended off the ground by installing a spring assembly. This is expected to save \$253 annually in hose damage.
Kathleen D. Martinez	City Clerk	\$25	Ms. Martinez is an Intermediate Typist. She suggested that the documenting of "form of" Council Policies be eliminated. This saves \$250 annually.
Linda H. Knarreborg Dean Klampe	City Clerk	\$20	Ms. Knarreborg is an Intermediate Typist, and Mr. Klampe is an Associate Administrative Analyst. They suggested that a memo used to answer copy inquiries be put in the form of a post card. This is expected to save \$219 annually.
William V. Nery	General Services	\$15	Mr. Nery is an Equipment Mechanic in the Equipment Division. He designed a tool to be used to remove chevrons on water pump replacements. This was felt to be an innovative equipment maintenance improvement.
