Thomas B. Wells	General Services	\$15	Mr. Wells is a Carpenter in the Buildings Division. He suggested that Carpenters carry spray paint to seal new raw wood installations. This protects the wood and improves appearance until a final painting can be done.
Donald E. Muffler	Fire	\$15	Mr. Muffler is a Fire Engineer. He revised Form FD-262, Bicycle Licensing Accounting Record. The revised form provides more information and eliminates renewals and new licenses being submitted on separate forms.
D. Gary Lee	Fire	\$15	Mr. Lee is a Fire Fighter. He suggested that the trees and bushes bordering the COB parking area be trimmed to improve drivers' sight. This was considered to be a significant safety improvement.
Rob Hilkert	Park and Recreation	\$15	Mr. Hilkert is a Utility Worker I in the Aquatics Division. He suggested that the "E-Z Reacher" tool be used for beach litter control. This tool enhances the ability to maintain sloped areas.
