Delorese J. Shafer	Risk Management	\$15	Ms. Shafer is an Intermediate Typist. She suggested that Form AC-468, Request For Direct Payment should be pre-punched with file holes. Savings are estimated at \$150 annually on a volume of 25,000 forms.
Lorin D. Mico	Park and Recreation	\$10	Mr. Mico is a Lifeguard Lieutenant in the Aquatics Division. He suggested that wooden lifeguard stands be replaced with stands made of galvanized pipe. This is expected to save \$564 annually in repair costs. This is a partial award pending a final 12-month review.
Paul E. Doman	Fire	\$10	Mr. Doman is a Fire Captain. He suggested that Fire equipment be equipped with wind and rain shields. This is expected to reduce drafts and wetness for Fire Fighters riding in the crew seats on Clark apparatus.
