
Adopted on MAR 27 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized to execute, for and on behalf of said City, an agreement with the CITY OF DEL MAR and the COUNTY OF SAN DIEGO for the construction of a traffic signal system at the intersection of Via De La Valle, Valley Avenue and Turf Road, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. 766061.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer the sum of \$30,000 from the Gasoline Tax Fund Unallocated Reserve (CIP 90-220) to CIP 68-001 (Cooperative Traffic Control Projects) and that the expenditure of \$30,000 is hereby authorized for the City's 25% share of the traffic signal system costs.
