

RESOLUTION NO. 223171 (R.79-1583)

VACATION OF WHALEY AVENUE AND 34TH STREET

MAR 27 1979

WHEREAS, it is proposed that WHALEY AVENUE and 34TH STREET be vacated;

WHEREAS, there is no present or prospective use for the streets either for the public street system for which the rights-of-way were originally acquired or for any other public use of a like nature that can be anticipated; and

WHEREAS, a revised street system will be dedicated and improved with the subdivision map of FRIEDRICK MANOR; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the rights-of-way were originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that WHALEY AVENUE and 34TH STREET, as more particularly referred to in Resolution of Intention No. 222966, is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that WHALEY AVENUE and 34TH STREET, as more particularly shown on Drawing No. 14498-B on file in the office of the City Clerk as Document No. 765771,

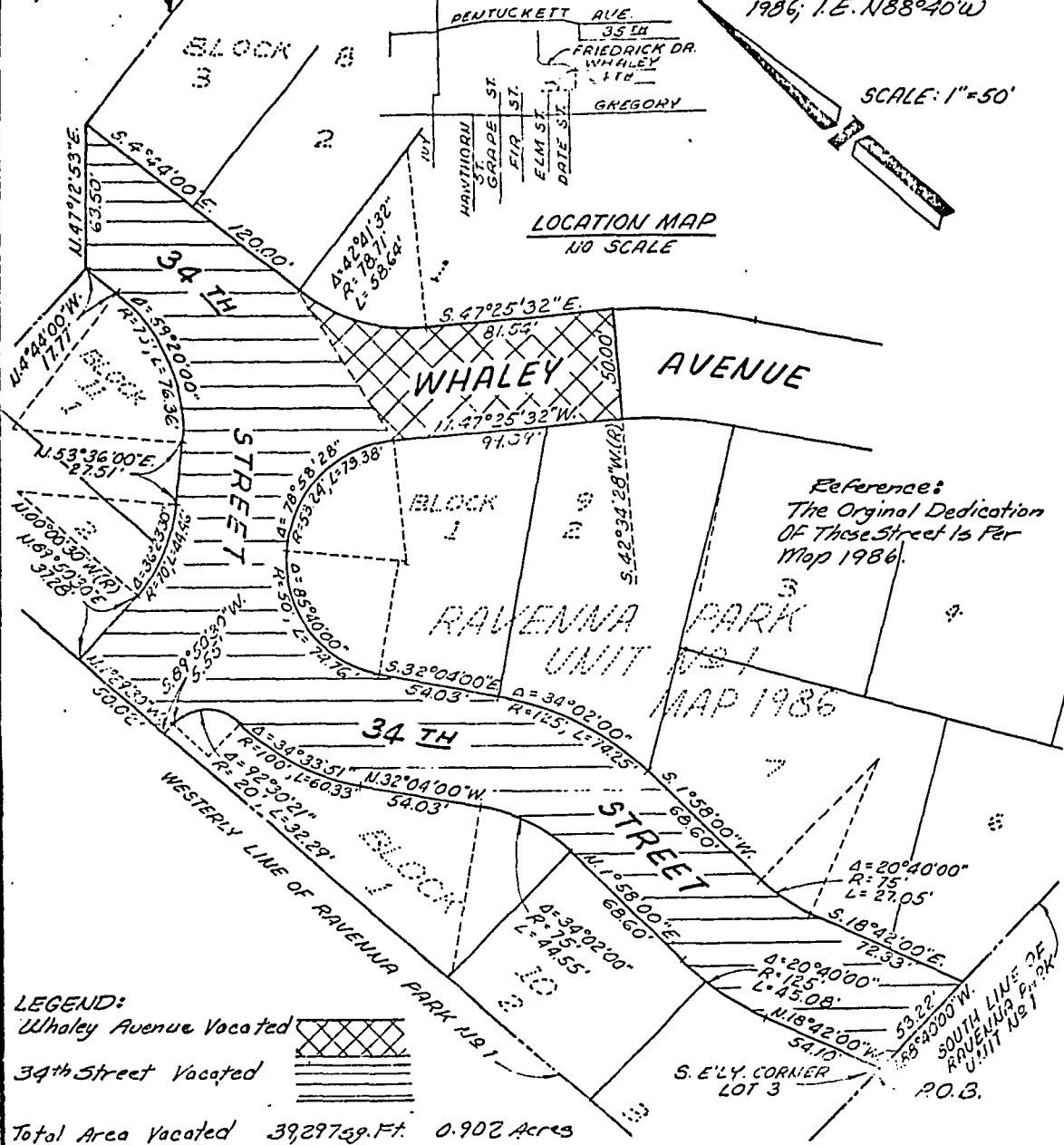
Portion of The Northerly


LOCATION MAP
