That the acceptance by the City Manager of that Grant Deed of the SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, a political subdivision in the State of California, executed in favor of The City of San Diego, conveying to said City all that portion of Lot 2, Pueblo Lot 1783, as more particularly described in said deed, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$66,700 from 1966 Park Bond Fund; \$3,144.87 from Subdivision Park Fee Fund 11504; and \$1,455.13 from Subdivision Park Fee Fund 17504 for acquisition of said parcel and related costs, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
