WHEREAS, the California Coastal Commission is reviewing proposed changes in the coastal zone boundary within the City of San Diego; and

WHEREAS, the San Diego Coast Regional Commission will be receiving public commentary regarding these changes; and

WHEREAS, the City of San Diego has been actively working on numerous planning issues regarding local coastal programs; and

WHEREAS, if areas outside of the current boundaries are added, much of the work of the City staff will have to be reprocessed to include the consideration of these added areas; and

WHEREAS, on November 13, 1978 and on March 5, 1979, the City Council took a position on coastal boundary readjustments, to include the Famosa Slough in the coastal boundary for protection of its coastal resources, and in opposition to any further increases in the Coastal Zone subject to the provisions of the Coastal Act; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That said City Council expresses its opposition to proposed boundary changes, with the exception of the Famosa Slough, which would result in increased areas subject to the provisions of the Coastal Act.
