


RESOLUTION No. 223183 (R- 79-1833)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the sole bid of HERZIG CORPORATION for INSTALLATION OF COMPLETE AUTOMATIC FIRE SPRINKLER SYSTEM FOR THE HOUSE OF HOSPITALITY BUILDING is hereby rejected.
2. That the bid of \$19,878.00 by LAWRENCE J. SANDAGE, An Individual DBA ACTION FIRE PROTECTION CO. for the CONSTRUCTION OF THE BALBOA PARK BUILDINGS-CODE UPGRADING - INSTALLATION OF AUTOMATIC FIRE SPRINKLER SYSTEM IN HOUSE OF HOSPITALITY BALLROOM in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 765664.
3. That the expenditure of \$31,000.00 from Balboa Park Facilities Fund 10501 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
