REVISED

WHEREAS, diesel fuel is no longer controlled by federal energy allocation; and

WHEREAS, the City of San Diego in cooperation with the County of San Diego have a contract with El Capitan Oil Company, Inc., of Lakeside wherein El Capitan is to provide fuel oil to the City of San Diego for the period of July 15, 1978 through July 14, 1979; and

WHEREAS, the City of San Diego has been advised by the El Capitan Oil Company, Inc., that their suppliers cannot provide El Capitan with adequate diesel fuel supplies; and

WHEREAS, the El Capitan Oil Company, Inc., has been unable to meet the City of San Diego's diesel fuel needs since January 5, 1979; and

WHEREAS, the City of San Diego has been forced to purchase diesel fuel at higher prices from other sources on the open market; and

WHEREAS, diesel fuel in the prevailing marketplace must be purchased, immediately, when available, from the source having it available; and

WHEREAS, present contacts with the diesel fuel marketplace indicate that competitive bidding cannot serve a useful purpose; and



WHEREAS, the public health, safety and welfare require that diesel fuel be available for fueling bulldozers, refuse trucks, fire trucks, dump trucks, and for heating oil; NOW, THEREFORE, BE IT RESOLVED, by the Council of The City of San Diego, that the Purchasing Agent is hereby authorized to purchase on the open market, diesel fuel, as may be required, for a period of six months commencing on April 1, 1979 and ending on October 1, 1979.
