WHEREAS, a residence located at 6784 Akins Avenue in Southeast San Diego caught fire on Tuesday, March 6, 1979; and

WHEREAS, the life of Michael Monroe, a two year old child who was trapped in the burning home, was threatened; and

WHEREAS, Chris Parker, a Madison High School junior, and Geoff Milke, a construction worker, heroically rescued the child from the burning residence despite threats to their own safety; and

WHEREAS, the child, who suffered second and third degree burns and from smoke inhalation, would have perished if left in the burning house thirty seconds longer; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that CHRIS PARKER and GEOFF MILKE are hereby commended for their heroic actions in saving Michael Monroe from his burning residence on Tuesday, March 6, 1979.
