APPROVING MAP OF MEADOW RUN UNIT NO. 1 AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, a Registered Civil Engineer, entitled "MEADOW RUN UNIT NO. 1 Being a subdivision of Lot 1022 of Bay Terraces Unit No. 12, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 7088, filed in the office of County Recorder of San Diego County on October 20, 1971.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Edenbridge Lane, Sandleford Way, Enborne Lane, Deerhurst Way, Deerhurst Court and the walkway for public purposes; and said streets and walkway are hereby declared to be public streets and a public walkway and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Tooma Street, adjacent and contiguous to Lots 1 through 11, 53, 54, 55, 56, and 80 through 86; in and to Alsacia Street,


adjacent and contiguous to Lots 20 through 35, and 62 through 76; and in and to Sandleford Way, adjacent and contiguous to Lots 43 through 48, all as shown on this map within this subdivision.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said streets and walkway are accepted on behalf of the public as heretofore stated, and that those certain abutters' rights of access as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, TREETOPS UNLIMITED, a joint venture, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of MEADOW RUN UNIT NO. 1.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
